1. DIMENSIONAL CONTROL PLAN

All dimensions below exclude the metal clasp unless stated. Width, depth and feature locations are controlled proportionally from the approved five-view art. The factory must enter measured millimetre values from the approved 100 mm golden sample in the blank controlled fields before production.

DIMENSION RELEASE RULE: no bulk cutting until the measurement table is completed from the signed golden sample and approved by Little World Studios. The 8-12 cm brochure range is a design envelope, not permission to vary finished size within a single SKU.

COLOUR CONTROL

Match Grandmother Owl's approved five-view artwork. The factory must supply physical fabric and embroidery swatches under controlled lighting. Pantone/brand colour references are assigned only after physical swatch approval; screen colours must not be used as production standards.

CHANGE CONTROL

No substitution of fabric, fill, thread, plating, loop, label, packaging supplier or construction method after golden-sample approval without a written deviation request, risk review and re-testing decision.

3. PATTERN, SEWING AND ASSEMBLY SEQUENCE

Step	Operation	Factory control point	Approval evidence
01	Create pattern from front, back, left, right and three-quarter views	Preserve silhouette, face position, markings and stable seated/standing posture shown	Pattern map and first toile
02	Prepare fabric direction and cutting markers	Consistent pile direction; identify mirrored pieces; control cutting distortion	Marker plan and cut-component check
03	Complete embroidery before main assembly	Use location template; secure thread ends; avoid puckering and sharp backing	Embroidery strike-off
04	Assemble appendages and character features	Turn fully; distribute fill; control symmetry and projections	Subassembly inspection
05	Install reinforced top loop	Capture loop and reinforcement in structural seam; no exposed raw edge	Cross-section sample
06	Join body panels	Factory specifies seam type, stitch density and allowance after fabric trial; lock seam ends	Seam trial and in-line standard
07	Turn, fill and close	Even hand feel; no voids, hard lumps or fill migration; secure ladder/closing seam	Filled first sample
08	Attach approved metal hardware	No burrs, sharp edges or plating defects; validate loop and ring closure	Hardware inspection + attachment test
09	Apply label and packaging	Correct code, batch, market operator and warning information	Final artwork approval
10	Final inspection and pack-out	Appearance, dimensions, seam integrity, cleanliness, metal finish and quantity	Inspection report and retained sample

GOLDEN SAMPLE GATES

Gate	Required approval
G1	Feasibility, quotation, MOQ and production timing
G2	Pattern prototype and dimensional table
G3	Fabric, colour, embroidery and hardware submissions
G4	Complete first sample and corrective-action round
G5	Production-representative sample for compliance testing
G6	Signed golden sample, final specification and packaging
G7	Pre-production meeting and purchase-order release

4. QUALITY, LEGAL AND COMPLIANCE RELEASE

The final applicable clauses depend on age grading, materials, construction, warnings and markets. A qualified compliance professional and accredited laboratory must confirm the test plan. This pack is not a certificate.

MINIMUM QUALITY PLAN

Stage	Checks
Incoming	Fabric lot/colour, fill, embroidery thread, hardware dimensions/finish, labels and packaging against approved submissions
In-line	Cut accuracy, pile direction, embroidery location, seam security, loop reinforcement, appendage symmetry and contamination control
Final	Finished dimensions, appearance, hand feel, seam/closure integrity, small-part/attachment assessment, sharp-edge/burr check, labels, barcode and pack-out
Shipment release	Signed inspection report, passing compliance documents, approved golden-sample comparison, batch records and carton specification
